## PRACTICAL PLACEMENT

All students in order to achieve a full assessment must undertake 160 hours of practical placement within an Aged Care environment. AEATS has dedicated Practical Placement Coordinators who will arrange your placement on your behalf. Placements can be undertaken as voluntary or paid work dependent on the individual arrangements between the student and the Aged Care facility.

Students are also required to have a current National Police Certificate available to our Practical Placement Coordinator at least 2 weeks prior to undertaking their Practical Placement. Practical Placement facilities reserve the right to reject students who do not have a clean National Police Certificate. If in doubt you should consult AEATS in relation to this matter prior to enrolment.

## COURSE OVERVIEW

This specialisation will provide sound employment opportunities within the aged care industries either in a facility of home care environment.

The CHC33015 Certificate III in Individual Support designed for individuals who want to work in the aged care industry either in an home and community care environment or aged care facility.

Students who complete this qualification are able to provide personal, in person care to the elderly in a variety of settings including people's homes, residential facilities, retirement villages, nursing homes and hospitals.

AEATS provides a range of delivery methods. For those who like the structure and support of class based learning AEATS delivers a 8 week program led by industry experts.

## AIMS OF THE COURSE

Students may do this course as an entry pathway into the aged care industry. Our CHC33015 Certificate III in Individual Support course is directed towards developing multi-skilled workers for the broad range of services supporting aged people in residential and community settings.

The course comprises of 13 units (7 Core and 6 Elective) Successful completion of this course requires the fulfilment of all 13 units of competency. It is possible to undertake a dual specialisation.

Students who complete this qualification are able to provide personal in person care to people in a variety of settings including people's homes, residential facilities, retirement villages, nursing homes and hospitals.

For those who require a greater deal of flexibility, AEATS offers this qualification via online delivery where you can study at your own pace.

Regardless of which mode of study you undertake, you will be required to be assessed within an appropriate environment which reflects the skills and activities of the specialisation you will undertake.

As soon as you enrol, you will receive access to the learning materials and assessments required to complete the knowledge component of your study.

You can complete and submit these assessments as quickly as you would like.

## **ADMISSION CRITERIA**

Applicants seeking entry into CHC33015 Certificate III in Individual Support course should meet the following criteria.

- Are 18 years old and above.
- Have successfully completed year 10 of secondary school or equivalent, or be of mature age.
- Be able to use and respond to written language, including some unfamiliar material in a variety of contexts.
- Successfully complete a Language, Literacy and Numeracy test (LLN).
- Obtain a satisfactory National Police Certificate.
- There are no prerequisite units of competence.

## Additional Criteria for Govt. Funding in NSW

- Primary place of residence must be in NSW.
- Must be an Australian Citizen /Permanent Resident /New Zealand Citizen & Humanitarian visa.

## **PRACTICAL PLACEMENT - ADMISSION CRITERIA**

AEATS has a dedicated practical placement coordinator who will arrange your placement on your behalf.

- Students are required to undertake 160 hours of practical placement within an AEATS approved work environment.
- Placements are undertaken on a voluntary arrangement (if you're already employed in the industry, discuss the site and supervision requirements with the practical placement coordinator as assessments do take place during practical placement which will need to be observed by an AEATS Assessor and approved workplace supervisor)
- Placements are undertaken according to the facilities schedules, with most on rotating morning (*7am-3.30pm*) or afternoon (*2.30pm-8.30pm*) shifts. Rosters are controlled by the facility.
- Practical Placements are completed Monday to Friday over four (4) weeks, or until the 160 hours is completed.
- AEATS students will not participate in placement hours on weekends or public holidays.
- Facilities reserve the right to reject students who do not have a clear National Police Certificate.

## NATIONAL POLICE CHECK - ADMISSION CRITERIA

Students are required to obtain a current National Police Certificate, showing a clear record to be accepted into most Aged Care Facilities. The facilities in which AEATS are associated reserve the right to reject students who do not have a clear National Police Certificate. Certificates are purchased via the Western Australian Police Force website and cost approximately \$51.50. To ensure we provide the facility with a current certificate, AEATS students will be notified by their practical placement coordinator when to order their certificate *(mid-way through classroom delivery)*. If in doubt, consult AEATS in elation to this matter prior to enrolment.

## COURSE ASSESSMENT

Assessment strategies are implemented for collecting evidence and making judgments about whether competency has been achieved by the student.

The assessments confirm whether an individual can perform to the standards expected in the workplace, as expressed in the relevant endorsed unit of competency.
